Intention to use your personal details:

Casa Mantana Bonaire will use your personal details for the following purposes:

- Managing your reservation and subsequent payment
- Sending you booking information, confirmations, invoices and updates.
- Send you our newsletter for which you will automatically be subscribed when you make a reservation with us. You can always manually unsubscribe for this newsletter.

Special and/or sensitive personal details that we use:

Our website is build on the **Weebly.com** platform, whose server is used to save your personal data and who acts as a data-processor. We have no influence on their privacy policy, which can be reviewed here <https://www.weebly.com/privacy>

Our booking system is managed by the external site **Freetobook**. In order to make a reservation through that system they will collect your personal information and store on their server. We have no influence on their privacy & cookie terms & conditions. You can review their policy during the booking process in the bottom right corner.

Click behavior and visit data General visitor data is recorded on the website. In this context, in particular the IP address of your computer, the possible user name, the time of retrieval and data sent by a visitor's browser can be registered and used for statistical analyzes of visit and click behavior on the website. We also optimize the functioning of the website. We try to anonymize these data as much as possible. This information is not provided to third parties.

Google Analytics

We use Google Analytics to keep track of how people have found us and which pages (subjects) are of interest in order to optimize our activities according to the preferences of our website visitors. The information obtained, including the address of your computer (IP address), is transferred to and stored by Google on servers in the United States. Google uses this information to keep track of how our website is used, to be able to provide us with reports about the website and to be able to offer its advertisers information about the effectiveness of their campaigns. Google may provide this information to third parties if Google is legally required to do so, or to the extent that such third parties process the information on Google's behalf. We have no influence on this.

Facebook and Instagram (social media)

Buttons are active on our website to promote or share pages on social networks such as Facebook and Instagram. These buttons are realized by a code that is supplied by Facebook and Instagram itself. This code places a cookie, among other things. Read the privacy statement of Facebook and Instagram (which can change regularly) to see what they do with your personal data that they process with this code. This also applies to other social media channels.

Our website and/or services don't have the intention to collect any personal details for persons younger than 18 years. Unless they have been granted permission by their parents/guardian. We, as owners of Casa Mantana Bonaire, are not able to check the person's age, hence we will advise parents/guardians to be continuously monitoring children's online activities, in order to avoid that personal details will be collected with parent's/guardian's permission.
